INSTRUCTION TO BIDDERS

All bidders, by the submission of their bid, covenant to be bound hereby and to perform in accordance with these instructions and conditions, as well as the invitation for bids and the specifications.

1. Any guarantee and/or warranties should be stated in the bid.
2. Bids shall be filed in a sealed envelope bearing the title "Tub Grinding Services" on the outside of the envelope. Its duly authorized representative must sign bids in the name of the bidding company.
3. Bids shall not be qualified in any manner.
4. Whenever an item is named or described, an item "equal" thereto maybe furnished.
5. The awarding authority shall make payments within thirty (30) days of deliver and acceptance.
6. The contracts shall be awarded to the responsible and responsive bidders who offer the Tub Grinding Services at the lowest bid price. The awarding authority may reject and all bids, if it is in the public interest to do so.

TERMS AND CONDITIONS

1. The tub grinder shall be a MORBARK 1300 or approved equal and shall include the operator.
2. The bidder shall only use the bid form supplied in this request for proposals.
3. Payment shall be by the hour and shall include tub grinder and operator, mobilization and demobilization, and all liability and workers compensation insurances.
4. Liability and Workers Compensation Insurance shall be supplied by the contractor covering the Town for these items.
5. The bid will be for the total cost to grind existing yard waste at the landfill, on an annual basis, and is based on an hourly rate for approximately 24 hours per year.
6. This is a yearly contract from July 1, 2018 through June 30, 2019 with two individual one year contract extensions possible, beginning July 1, 2019 and another beginning July 1, 2020, if agreeable with the town and service provider. The contract extensions shall be at the current bid price under the same terms and conditions.
