

[COMPLAINT AND WARRANT TO SEARCH FOR LIQUORS.]

To ROBERT M. FRANKLIN, Esq., Justice, GEORGE H. KELLEY, Esq., Clerk of the District Court of the First Judicial District in the County of Newport, in the State of Rhode Island and Providence Plantations

Deputy Sheriff, Chief of Special Police Constable, and a legal voter of the City Town of Newport in said county, on oath complains, in the name and behalf of the State, that certain intoxicating liquors, to wit: a certain quantity of rum, being about and not exceeding one hundred gallons; a certain quantity of whiskey, being about and not exceeding one hundred gallons; a certain quantity of gin, being about and not exceeding one hundred gallons; a certain quantity of brandy, being about and not exceeding one hundred gallons; a certain quantity of ale, being about and not exceeding one hundred gallons; a certain quantity of wine, being about and not exceeding one hundred gallons; a certain quantity of strong beer, being about and not exceeding one hundred gallons; a certain quantity of lager beer, being about and not exceeding one hundred gallons; a certain quantity of other strong and malt and intoxicating liquors, being about and not exceeding one hundred gallons; a certain quantity of mixed liquors, a part of which is ale, wine, rum, and other strong and malt and intoxicating liquors, being about and not exceeding one hundred gallons; contained in certain barrels, kegs, jugs, jars, bottles, decanters, and other vessels; were and still are kept and deposited by

..... laborer, in a certain building (dwelling house,) numbered then and there situate on

..... Street, so called, in the City Town of Newport..... in said district, (used and occupied exclusively as such, no tavern, store, grocery, eating-room, or place of common resort, being kept therein) for sale within this State in violation of law. And said complainant has reason to believe and does believe that intoxicating liquor, such as is above mentioned, has been sold in said dwelling-house above mentioned, (or has been taken from the house above mentioned for the purpose of being sold,) by the occupant of said house, and by his permission, contrary to law, within one month next before the day of making this complaint and is now kept in said house for sale, contrary to law; and his belief aforesaid is founded on the following facts and circumstances:—

..... against the statute, and the peace and dignity of the State. Wherefore the complainant prays for a warrant to search said..... for said liquors and vessels and that the same may be declared forfeited to the State.
